# Recommendations and Interim Report

### **Interim Report**

- Still in draft form and under review
- Executive summary focuses on non-workgroup activity
- Second row of recommendation tool included from every recommendation

## First-Round Recommendation s

- 35 Recommendations
- Every pillar has at least 2 recommendations that fit within it
- 5 workgroups produced more than one recommendation
- 4 recommendations include major changes to NY Connects

### First-Round Recommendation s (Cont'd)

In-Community Services	Enhance NY Connects with expanded capacity, cultural and linguistic competency, accessibility, and marketing; embed NY Connects into both the community and health care systems	
PACE	New York State will implement initiatives to increase PACE enrollment by increasing accessibility and awareness of PACE. Includes a NYConnects component.	
Technology	Expand NY Connects to include a centralized repository of technology resources, trainings, and supports	
Transportation	Integrate 211 and NY Connects (along with other public resource database and navigation services) with Mobility Management across NYS regions	

# Recommendations From Outside the Workgroups

- Create a path for informal caregivers to get credit for their caregiving experience in transitioning to a career in caregiving.
- Lower requirements for experienced professional caregivers to become instructors in training/licensing programs.
- Establish a hotline for older adults who are lonely. Note that some older adults are misusing ambulance services as a response to loneliness.
- Value-based payment (VBP) is a preventative investment. It should be encouraged in several ways: by enforcing penalties against market participants unwilling to participate in VBP models; by leveraging technology to reduce the administrative burdens associated with VBP programs; by supporting industry efforts to extend VBP programs to pharmaceuticals and pharmaceutical companies; and by allowing more flexibility for innovation among payors and providers.
